First round will include the review of a hotel development on the eastern precinct 2028 Masterplan update will commence planning in 2026 Body scanners algorithms have been altered to the American algorithms resulting in less sensitive areas being raised. Next generation of screening will be implemented with a higher scan resolution and higher throughput rates with less false scans plus an increase efficiency as well Airport Operations & Check in process is being refined with planning for transition to Safety fully self-serve which will go live after July school holidays Compliance testing has been - QF A321 deployed into LST went successful.
